New Starters

- For all new starters there will be a non-refundable Registration Fee of £60 (includes VAT)
- A deposit will be payable for all new pupils.
- £180 (includes VAT) of the total deposit is an Acceptance Fee, to cover administrative costs. The remainder will be refunded against the fees of the last term in which the child is due to leave the School, or will be held against any amounts outstanding.

Sibling Allowances

- Where a child has a brother or sister in the school an allowance of 5% will be made against the younger child's fees.
- Where a child has two other siblings in the school an allowance of 5% will be made against the youngest child's fees and 10% against the second youngest. Any allowance is subject to satisfactory payment of fees.
